Welcome to www.comigo.com (together with its subdomains and Content, the “**Site**”). Your privacy is important to us. To better protect your privacy, we provide this privacy policy (“**Privacy Policy**”) explaining the online information practices of Comigo Ltd. and its affiliates (“**Comigo**”, “**we**”, “**our**” or “**us**”) and the choices you can make about the way we collect and use your information. 1. Consent and Modification

By using this Site, you consent to the terms of our Privacy Policy and to Comigo's processing of Personal Information (as defined below) for the purposes set forth herein. If you do not agree to this Privacy Policy, please do not use our Site. We reserve the right, at our discretion, to modify this Privacy Policy at any time, which modification will be effective 10 days following the posting of the modification to the Site or providing notice to you, whichever occurs first, and will apply to causes of action arising after the effective date of the change. We will inform you regarding such modifications by either notifying you via your email address or by posting such latest changes on the Site. You should continue checking the Site for changes. Your continued use of this Site 10 days following the posting of changes to this Privacy Policy or providing notice to you, whichever occurs first, will mean you accept those changes.

2. Introduction
